

ORDINANCE NO. 62

AN ORDINANCE INCREASING THE RATES CHARGED BY THE CITY OF CHERRY VALLEY, ARKANSAS, FOR THE USE OF ITS WATER AND SEWER SYSTEMS.

WHEREAS, The City of Cherry Valley, Arkansas, (City) owns and operates water and sewage facilities and has determined that to continue to offer these services to the inhabitants of the City, it will be necessary to increase the sewage and water rates; and

WHEREAS, The City has been authorized by general election to issue general obligation bonds for the improvement of the sewage and water system, and to effectuate this improvement, the increased rates are necessary; and

WHEREAS, The rates now charged by the City for use of the sewer and water system are the rates established in 1963, and the cost of offering the services rendered to the inhabitants of the City has increased considerably.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Cherry Valley, Arkansas:

Section 1. That the water rates for the use by the inhabitants of the Cherry Valley water and sewage system be as follows:


First 2,000 gallons	\$4.50 minimum
Next 3,000 gallons	1.70 per 1,000 gallons
Next 5,000 gallons	1.15 per 1,000 gallons
Next 10,000 gallons	.95 per 1,000 gallons
All over 20,000 gallons	.80 per 1,000 gallons

Section 2. The City hereby establishes the following rates for use of the sewer system: A flat rate of \$3.00 per month, plus thirty per cent (30%) of the monthly water bill.


Section 3. This Ordinance shall take effect and be in force immediately after its passage.

EXCERPTS FROM MINUTES OF MEETING OF THE  
CHERRY VALLEY CITY COUNCIL,  
HELD September 24, 1979

The City Council of the City of Cherry Valley,  
Arkansas met in special session at its regular meeting place  
in Cherry Valley, Arkansas, at 10 o'clock a.m., on  
the 24th day of September, 1979. The following were present:  
Mayor Howard H. Beasley; City Recorder Thomas J. Rowland;  
and Aldermen C. L. Carter, Billy Huey and Bill Carwell

Absent: Forrest M. Wood

The Mayor stated that consideration should be given to an  
ordinance authorizing the issuance of water and sewer revenue  
bonds. This was a  
matter with which the Council was familiar and after a discussion,  
Alderman Carter introduced an Ordinance entitled:

AN ORDINANCE AUTHORIZING THE CONSTRUCTION OF EXTEN-  
SIONS, BETTERMENTS AND IMPROVEMENTS TO THE WATER  
AND SEWER SYSTEM OF THE CITY OF CHERRY VALLEY,  
ARKANSAS; AUTHORIZING THE ISSUANCE OF WATER AND  
SEWER REVENUE BONDS FOR THE PURPOSE OF FINANCING  
A PORTION OF THE COST OF THE CONSTRUCTION; PROVIDING  
FOR THE PAYMENT OF THE PRINCIPAL AND INTEREST ON THE  
BONDS; PRESCRIBING OTHER MATTERS RELATING THERETO;  
AND DECLARING AN EMERGENCY.

and the City Recorder read the Ordinance in full.

Alderman Carter, seconded by Alderman Huey, moved that the rule requiring the reading of an ordinance or resolution in full on three different days be suspended and that the Ordinance be placed on its second reading. The Mayor put the question on the adoption of the motion and the roll being called, the following voted aye:

Thereupon the Mayor declared that at least two-thirds of all members of the Council having voted in favor of the motion to suspend the rule, the motion was carried and the rule suspended. The Ordinance was then read by the City Recorder .

Alderman Carter, seconded by Alderman Huey, then moved that the rule requiring the reading of an ordinance in full on three different days be further suspended and that the Ordinance be placed on its third reading. The Mayor put the question on the adoption of the motion and the roll being called the following voted aye:

The Mayor declared that at least two-thirds of all members elected to the Council having voted in favor of the motion to suspend the rule, the motion was carried and the rule suspended. The Ordinance was then read by the City Recorder .
